Dues payments to Gold Coast Builders Association (GCBA) are NOT tax deductible as charitable contributions for federal tax purposes, but may be deductible as an ordinary and necessary business expense. Your dues for annual membership to GCBA include \$150 for membership in National Association of Home Builders (NAHB) and \$85 for membership in Florida Home Builders Association (FHBA). A portion of your dues to NAHB and FHBA is used for lobbying and is not tax deductible for tax purposes. \$10 of your dues for membership in FHBA is allocated to FHBA political action committee and \$45 of your dues for membership in GCBA is allocated to Floridians for Sensible Growth, Citizens for Economic Growth, Gold Coast Alliance for Jobs, Families for Affordable Housing and Floridians for Environmental Excellence, political action committees for lobbying and political activity, allocated to ensure support of candidates who are positive for industry. This allocation of your dues to the political action committees is not tax deductible as a business expense. These allocations are optional and if you do not want your dues to be allocated to any political action committees, please indicate so and these allocations will be retained in the Associations' operating funds.
